Bright Ideas Grant Program

ABOUT THE PROGRAM

The Bright Ideas Grant Program, sponsored by Coos-Curry Electric Charitable Foundation, provides grants for teachers to improve education in local classrooms for innovative projects in grades K-4, 5-8 and 9-12 that would not otherwise be funded. The program is funded through unclaimed capital credits from Coos-Curry Electric Cooperative.

ELIGIBILITY

Oregon certified public or private school teachers in grades K-12 within the following school districts qualify to apply: Brookings, Gold Beach, Port Orford, Bandon, Coquille and Myrtle Point.

JUDGING CRITERIA

Projects will be judged based on innovation, goals, learning objectives, student involvement and budget.

INDIVIDUAL GRANT LIMIT

Individual projects can be funded up to \$1,500. Teachers are limited to one grant proposal per round of funding.

TERM

Grants will be awarded annually based on merit and must be used within the current school year. Applicant will be required to provide a follow-up report about the funded project.
